



## 4. FIRST AID MEASURES

### First aid measures for different exposure routes

<b>General advice</b>	If symptoms persist, call a physician.
<b>Eye contact</b>	Immediately flush with plenty of water. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Keep eye wide open while rinsing. If symptoms persist, call a physician.
<b>Skin contact</b>	Immediate medical attention is not required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. If skin irritation persists, call a physician.
<b>Inhalation</b>	Immediate medical attention is not required. If symptoms persist, call a physician. Move to fresh air in case of accidental inhalation of vapors or decomposition products.
<b>Ingestion</b>	Clean mouth with water and drink afterwards plenty of water. Never give anything by mouth to an unconscious person. Call a physician. Do NOT induce vomiting.
<b>Self-protection of the first aider</b>	Use personal protective equipment.

## 5. FIRE-FIGHTING MEASURES

### Suitable Extinguishing Media

Use. Dry chemical. Carbon dioxide CO<sub>2</sub>. Water spray. Alcohol-resistant foam.

### Unsuitable extinguishing media

Decomposition by contact with water may generate vapors which can be ignited by heat or open flame.

### Specific hazards arising from the chemical

Keep product and empty container away from heat and sources of ignition. Risk of ignition.

**Methods for containment** Prevent further leakage or spillage if safe to do so.

**Methods for cleaning up** Dam up. Use personal protective equipment. Cover liquid spill with sand, earth or other noncombustible absorbent material. Take up mechanically, placing in appropriate containers for disposal. Clean contaminated surface thoroughly. Soak up with inert absorbent material. Pick up and transfer to properly labeled containers. Take precautionary measures against static discharges.

**7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Advice on safe handling** Use only in area provided with appropriate exhaust ventilation. To avoid ignition of vapors by static electricity discharge, all metal parts of the equipment must be grounded. Keep away from heat, sparks and open flame. No smoking. Use personal protective equipment as required. Do not breathe dust/fume/gas/mist/vapors/spray. Take necessary action to avoid static electricity discharge (which might cause ignition of organic vapors).

**Storage Conditions** Keep containers tightly closed in a cool, well-ventilated place. Keep away from heat. Keep in properly labeled containers.
